

**WAIVER AND RELEASE OF LIABILITY
AGREEMENT TO PARTICIPATE**

READ BEFORE SIGNING

I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the Company immediately. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless Fleet Feet Sports Montgomery, MetroFitness Montgomery, OrangeTheory Fitness Montgomery, Hope Inspired Ministries, their agents, employees, coaches, volunteers, officers, directors, franchisors, successors and assigns, the City of Montgomery and any and all sponsors, their representatives and successors ("Releasees"), with respect to any and all injury, disability, death, or loss or damage to person or property associated with my presence or participation, whether arising from the negligence of the releasees or otherwise, to the fullest extent permitted by law.
